DETAILS:

1. \$10.00 donation PER CHILD includes the Junior Firefighter Obstacle Course and lunch. Please make your check payable to the City of Stow. City of Stow will transfer all donations for this event to the American Cancer Society.
2. All children must be accompanied by a parent or legal guardian at all times. No child may be dropped off and left unaccompanied.
3. Lunch is included with the \$10 donation. If your child has allergies or specific needs, please plan accordingly as there is no variety or choice for the lunch being provided. If adults wish to eat lunch with their child/children, you are welcome to do so if you make a \$5 donation for your meal on the day of the event, at the event.
4. Children should dress in weather appropriate play clothes **and must wear closed toe tennis shoes** TO actively participate. This event will be rain or shine.
5. Each child will be required to have a waiver signed by their parent, legal guardian or responsible adult in order to participate. If pre-registering more than one child, a waiver must be signed for **EACH child.**
